Rules and Regulations

The Responsible party shall;

1. Report any injuries, accidents, facility damage, dangerous or unsafe conditions and any unusual or suspicious situations to the Township as soon as possible after the occurrence of discovery of the problem.
2. Comply with all federal, state and local codes
3. Comply with all industry guidelines in the care, maintenance, and placement of its equipment used on the fields
4. Indemnify, defend and save the Township free and harmless from and against any and all damages, costs and expenses, including reasonable attorney fees, to any person arising from the Teams use of the ball fields, including but not limited to its maintenance of the field.
5. Comply with Township regulations concerning the parking of vehicles while using the ball field and encourage compliance by participants and spectators.
6. The field must be left in a clean condition
7. Animals are not permitted on the field unless they are trained to assist a special needs owner.
8. Township officials, employees and law enforcement have the authority to enter the field at any time.
9. If it has been determined by the Maintenance crew that the field has been damaged and repairs to the facility or equipment need to be made the Township will charge the responsible party for the time and cost of equipment/repairs.
10. All Jerome Township Park rules apply as the field lies within 'Harry Wolfe Park'. See attached park rules if you have any questions.

Fees

1. The field is available on a first-come first-serve basis once the baseball lottery takes place in early spring.
2. The fee must be paid at the time of reservation, or the reservation will not be secured.

Cancellation Policy

1. Weather related cancellation- All cancellations must be received in our office at least 1 hour prior to the reservation time that you wish to cancel. If this time is not during business hours, you can leave a voice mail on the administration voicemail or send an email to the baseball contact at the Jerome Township office to be eligible for a make-up date at no charge.
2. Other cancellations – all other cancellations are not subject to make-up date unless at the discretion of the Township Staff. All cancellations must be received in our office at least 1 hour prior to the reservation time that you wish to cancel. If this time is not during business hours, you can leave a voice mail on the administration voicemail or send an email to the baseball contact at the Jerome Township office
3. Carry over dates – dates will not be carried over between calendar years. All make up dates must be used by the end of the present year. No unused dates will be carried over the following year.
4. No cash refunds – all weather-related cancellations will be eligible for a makeup date at an available time and cannot be refunded in cash.

Definitions

The responsible party is responsible for all persons in the group or organization using the facility.
